## Epidemic New Life & Picking-up Nice Items in Auction

**The total highest-bidding amount made from the AEA joint auction was around NTD 72,530,000.**

With the coronavirus pandemic relief, the joint auction held on the “first” “Tuesday” of every month, starting at “3” p.m. by the branches of AEA started to recover and get back into the swing of things.

The auctions of the personal properties suspended by each branch due to the consideration of epidemic prevention started to be held gradually, and brought back energy for the epidemic new life movement.

The AEA joint auction held on the “first” “Tuesday” of every month, starting at “3” p.m. in the afternoon of July 7th. The total highest-bidding amount made from the auction was NTD 72,539,502 and will be collected by the national treasury.

The personal properties provided for auctions included the automobiles from Ford, Kuozui, Yulon, DAF, CMC, Kuozui Truck, heavy motorcycle with yellow license plate from Kymco, T1 from

SYM, jade ornaments, wooden tables and chairs, treasure bowl, glazed horned fish, imitation jade in the shape of a horse, imitation jade in the shape of Qilin, golden plate with dragon and phoenix decorations, Royal Salute gift set, short-sleeve t-shirt with crew neck, far infrared eye masks, caps, mats, hair bands, folding fans, cool scarfs, gas stoves, etc. The total highest-bidding amount made from the auction was NTD 2,039,813.

The total highest-bidding amount made from the final bid of the real properties was NTD 70,499,689. The one with the highest final bid was located at land no. 299, Minlun Section, Yuanlin City, Changhua County and auctioned by Changhua Branch. The amount made from the final bid was NTD 20,200,000. The land is located at land no. 69-68, Raopingcuo Section, Tianwei Township, Changhua County and auctioned by Changhua Branch. The amount made from the final bid was NTD 1,280,000. The building is located at the 3F.-1, No. 267, Minan W. Rd., Xinzhuang Dist., New Taipei City and auctioned by New Taipei Branch. The amount made from the final bid was NTD 7,812,000. The lands located at the land no. 957 and 984, Dongzhuang Section, Toufen City, Miaoli County and auctioned by Hsinchu Branch. The amount made from the final bid was NTD 310,000. The land located at land no. 0580-0000, Gongguan Section, Shalu Dist., Taichung City and auctioned by Taichung Branch. The amount made from the final bid was NTD 9,519,999. The building and its land are located at Construction No. 4315, Dongshizi Section, East District, Taichung City and auctioned by Taichung Branch. The amount made from the final bid was NTD 6,987,777. The building is located at 19F.-8, No. 1, Wenqing 2nd Rd., Guishan Dist., Taoyuan City and auctioned by Taoyuan Branch. The amount made from the final bid was NTD 7,841,200. The building is located at No. 59, Xing

2nd St., Taoyuan Dist., Taoyuan City and auctioned by Taoyuan Branch. The amount made from the final bid was NTD 7,740,345. The 3-floor house located at Dulan Rd., Donghe Township, Taitung County and auctioned by Hualien Branch. The amount made from the final bid was NTD 3,800,000. The building located at Construction no. 1212, 2 subsection, Chengzhong Section, Zhongzheng District, Taipei City and auctioned by Taipei Branch. The amount made from the final bid was NTD 4,835,888. The building located at 4F., No. 284-1, Xizang Rd., Wanhua Dist., Taipei City. The amount made from the final bid was NTD 3,439,000. The two lands are located at Fuqian Section, West Central District, Tainan City and auctioned by Tainan Branch. The amount made from the final bid was NTD 1,917,000. The joint auction results were good

In order to respond to the development of COVID-19, AEA authorized the branches to determine whether to hold the auction of personal property or real property in the joint auction held on the “first” “Tuesday” of every month, starting at “3” p.m. every month.

The auction of real properties will be held either by communication bidding (no on-site bidding will be allowed) or allow communication bidding and on-site bidding concurrently.
