The total amount made from the highest-bidding of the joint auction held by AEA reaches a new record of NTD 204,498,659

Today (April 12), AEA holds the joint auctions held on the “first” “Tuesday” of every month, starting at “3” p.m. every month, and the public of the whole nation participate the auction actively. The total amount made from the highest-bidding of the auction reaches NTD 204,498,659, and creates a huge income for the treasury.

The total amount made from the highest-bidding of the real properties is NTD 169,572,709. The focus of the auction is “Uptown Treasury” located in Xindian District, New Taipei City and auctioned by Taipei Branch, which is commissioned by the Taipei District Prosecutors Office. It is located in the middle of Xindian, near the MRT Chizhang Station and has a large shopping center around, the life function of the area is excellent. The one with the second highest-bidding amount is a building located at Jingguo Road, Taoyuan District, Taoyuan City and auctioned by Taoyuan Branch. The total amount made from its highest-bidding is NTD 27,200,000. The lands located in Luzhou District

and Zhonghe District of New Taipei City, which are auctioned by New Taipei Branch for NTD 25,046,038 and NTD 6,411,000 respectively; the lands located in Cigu District, Tainan City and auctioned by Tainan Branch for NTD 17,205,554; the land located in Niasong District, Kaohsiung City and auctioned by Kaohsiung Branch for NTD 10,026,000; the lands located in Luodong Township, Yilan County and Qidu District, Keelung City and auctioned by Yilan Branch for NT\$4,951,264 and NT\$1,262,848, respectively; the lands located in Ligang Township and Hengchun Township, Pingtung County and auctioned by Pingtung Branch for NT\$1,517,450 and NT\$1,370,000, respectively; the land located in Dounan Township, Yunlin County and auctioned by Chiayi Branch for NT\$1,523,000; the land located in West District, Taichung City and auctioned by Taichung Branch for \$888,888; there are many other real properties with good quality are auctioned by the branches, allowing the public to purchase real properties at affordable prices.

The total amount made from the highest-bidding of personal properties is NTD 34,925,950. The most eye-catching property is the "Gold Auction" held by Hsinchu Branch and commissioned by Miaoli District Prosecutors Office. With the growing price of gold, the golden nuggets, golden ingots and two Rolex watches which seized by the branch for the fraud case of HungFuHai Group and provided for the auction attract the public to participate the bidding. The total amount made from the highest-bidding of the said items reaches NTD 29,745,000, and exceed the basic price. In addition, 25 boxes of Yuchuan Sake, Yuchuan Special Wine, and Yuzun Whiskey are auctioned by Taipei Branch for NTD 25,400; there are also many stocks of various companies are auctioned by the branches, including the stocks of Huatai, Sunny Bank, Panhsin, Uni Air, PACIFIC ELECTRIC WIRE & CABLE CO., LTD, and FORTUNE MOTORS CO., LTD. For automobiles, a private sedan is auctioned by Pingtung Branch for NTD 352,000; a Toyota SUV is auctioned by Taichung Branch for

NT\$300,000; a Honda private sedan is auctioned by Kaohsiung Branch for NT\$200,000; a Mercedes-Benz automobile is auctioned by New Taipei Branch for NT\$100,000; and the rest of the auctioned items included food, cloth, housing, transportation, education, and entertainment items, all of which are auctioned by the branches for affordable price with good quality. The public has the chance to purchase any item they see on-site.

AEA reminds the public that the epidemic situation is getting more serious after the holidays, so the public should work together to fight against the epidemic, follow the relevant epidemic prevention measures set by CECC, wear masks, keep social distance, cooperate with the venues to take body temperature, seek medical assistance when having fever, and do not enter auction venues to avoid causing breaches in epidemic prevention.
